Specific dates of visits will be scheduled directly with you.

The fee for the Full Service yearly program is \$500 per month. That includes employee training, individual documentation of instruction received, regulatory compliance consulting services and multiple safety meetings for different groups of employees.

If two or more members are in close proximity and want to share the cost of the program, please contact us so we can make arrangements to split the program costs and mileage.

If you prefer, a single monthly safety meeting alone is \$300 a month with a yearly agreement. An occasional session for MPUA members who have not signed up for the full year is \$500 per session. A 10% administration fee will be added to the base fee, plus, a pro-rated mileage charge will apply to each visit, regardless of level of participation.

You will receive a bill quarterly for the previous three month's visits.
